

REGISTRATION OF BIRTH OUTSIDE SRI LANKA

1. *Child should be under the age of 21 at the time of registration.*
2. *One of the parents should be a Sri Lankan citizen during the birth of the child to be eligible for a birth registration.*

- *Application will not be processed if any of the following required documents are not provided.*
- *Translations of birth and marriage certificates of parents are not acceptable as original documents.*

- *Please fill registration **form “B4”** if the child is under the age of 3 months.*

Additional Information

- **Two sets of photocopies** should be submitted along with the originals of the above supporting document.
- **Declaration form** should be filled to declare that the applicant (father/Mother) has not acquired any other citizenship of a country other than Sri Lanka at the time of child's birth.
- **Letter of explanation** for late declaration addressed to the Registrar General, Registrar General's office, Colombo would be required stating the reason for not declaring the birth within the prescribed three month period.
- **Attestations** are not required if documents are submitted directly to the Sri Lankan consulate office in Melbourne, however documents that are posted needs to be certified by authorised Australian certification bodies(Lawyer, Doctor, Justice of peace, Police officer or pharmacist)
- **Payments** for applications are only accepted by cash at the Sri Lankan consulate office in Melbourne; all postal applications should include a postal order/ money order/ bank draft drawn in favor of "**Consulate General of Sri Lanka**"
- Application fee AUD\$100 (late registration fee of AUD \$12 will be charged per year if the registration will be done one year after the birth of child)

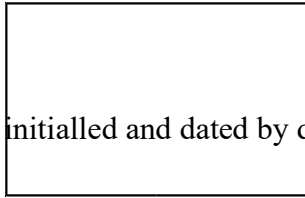

1. Specify all the particulars relating to the dates, including the month and last portion of the year, in letters, for instance, first day of January, 1953 (fifty-three).
 2. Tamils or Moors must be described as “Ceylon Tamil” or “Ceylon Moor” or “Indian Tamil” or Indian Moor”, as the case may be.
 3. Mother’s full postal address should be given in addition to stating her permanent residence. In describing permanent residence, her village and revenue division or if a proclaimed town, the ward and street should be given. In the case of an estate Indian labourer, the name of the estate and revenue division should be given.
 4. In the case of a person born in wedlock, information should be given of the paternal grandfather and great-grandfather and in the case of a person not so born, and not legitimated by the subsequent marriage of the parents, information should be given of the maternal grandfather and great-grandfather.
